In 2021, Hospice of Lenawee Volunteers provided a total of **5,861** hours of service (4,527 direct care and 1,334 indirect care). The cost savings to the organization was a remarkable **\$92,359**. Our volunteers continue to provide constant support to a Mission they believe in.

The Hospice Home is the only inpatient facility in Lenawee County that was built for the community by the community and provides compassionate end-of-life care to patients and their families. The Hospice Home models the "Heart of Caring" in many ways providing a home atmosphere and understanding what is important to each patient and family in their final days. You might see staff taking a patient outside in their bed

on a warm Spring day to enjoy the sun or planning a birthday party with decorations and food. We even have a kitchen staff who enticed a patient's appetite with creatively decorated pancakes in the shapes of animals and our patient ate every bite!"








OUR BEREAVEMENT SERVICES

66 Tospice of Lenawee provides complimentary bereavement Leservices to anyone who has suffered a loss in our community. In recognizing the importance of reaching youth who have suffered a significant loss in their lives, Hospice of Lenawee's Bereavement Department developed Kaleidoscope, a school-based grief support program for youth, grades K-12. Kaleidoscope meets the grief and loss needs of youth throughout our community at no cost to students, parent/ guardians, or schools. Offering support within the schools is an important aspect of this program as transportation can be a barrier for youth and their families, especially in the midst of grief. This partnership allows counseling offices to address the many referrals received each school year from parents and school staff in a timely manner."

in confronting possible unresolved grief, which can lead to depression, hopelessness, and other mental health issues, such as anxiety disorders and substance use disorders. The monitoring and encouragement of grieving youth provided through the Kaleidoscope Program ensures that each student has the support, sense of confidence, and coping strategies necessary to become healthy and resilient adults, of mind, body, and spirit.



IN 2021, 467 Hospice of Lenawee families were served, along with 130 community bereavement clients. In addition, 81 students in all 11 Lenawee County School Districts were served through our school-based program Kaleidoscope and 35 students received crisis management support.



The CAHPS Hospice Survey consists of 57 questions and is administered to primary informal caregiver of the decedent who died while receiving hospice care. CAHPS Hospice Survey administration begins two months following the month of patient death.




REVENUE


