OUR HISTORY



Hospice of Lenawee, Inc. is a nonprofit organization, incorporated in the State of Michigan in 1982.

The organization was fully supported by charitable donations until 1990 when the program met the criteria to become Medicare certified.

The program has consistently grown since early 2004 when the average daily census (number of patients) was under 20.

In 2008, our Board of Directors made the decision to embark on a Capital Campaign to serve the needs of those patients who needed 24-hour hospice care and for whom home care was either impractical or impossible.

After a study was conducted and confirmed the need for an 8-bed in-patient facility, Hospice of Lenawee began the journey to raise 5 million dollars.



In 2016 we experienced our largest growth and were staffed with a full disciplinary team to serve up to 150 patients and their families daily.

Throughout the years, we have provided end-of-life care and bereavement support to thousands of patients, families, caregivers, and community members. Our Board of Directors and Leadership Team are committed to enhancing our programs and sustaining Our Mission into the future.

We were fortunate that a majority of our Volunteers were able to return to doing what they love in 2022 by serving Our Mission. Our total volunteer hours increased substantially (approximately 50%) between 2021 and 2022."

In 2022, Hospice of Lenawee Volunteers provided a total of 8,770 hours of service (7,162 direct care and 1,608 indirect care). The cost savings to the organization was a remarkable \$248,615. BEREAVEMENT SERVICES

Tospice of Lenawee provides grief support services to anyone Lin the community who has suffered a loss in addition to supporting our Hospice families. Due to generous community support, there are no fees associated with our Community Bereavement Services. In recognizing the importance of reaching our youth who have suffered a significant loss, the Hospice of Lenawee Bereavement Department has developed a youth-based grief support program called "Kaleidoscope." This program was created to meet the needs of our community as grief can have a major impact on learning, processing thoughts, and retaining information. It is our universal goal to provide each child/adolescent with the tools and supports necessary to becoming a healthy productive adult. Offering support within schools is an important aspect of this program, as transportation can be a barrier for youth and their families, especially during the midst of grief. This partnership allows for a more comprehensive approach to address the needs of each child/adolescent and to also provide services in a timely manner.

Because grief can trigger overwhelming feelings, the Bereavement Department works to help support growth and healing.



In 2022, we collaborated with the Adrian Center for the Arts for our Spring and Fall "Mending Hearts" retreats. This platform of utilizing art therapy in a group setting was a powerful means for children and families to express their feelings and receive support from others. These important interactions between the participants and the art process helped each individual move from isolation and loneliness to connection and empowerment."
